Investment Objective


The fund invests in various asset classes, primarily equities and bonds. The fund invests in securities and/or target funds that promote either environmental and/or social characteristics and/or have sustainable investments as objective. Target allocation to equities always ranges between 0 % and 60 % maximum, and to bonds between 0 % and 85 % at the most. Money market and alternative investments are also possible. Allocations to each asset class may fluctuate and will be adapted to reflect Fund Management's assessment of the capital markets. The fund structure is oriented towards a balanced portfolio over the medium to long term. The fund's investment objective is to generate income and to attain capital growth over the long term.


